The ability to generate music on demand, customized to a users needs, helps content creators to save time, money, and add amazing production values to their content.

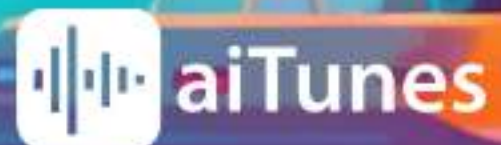

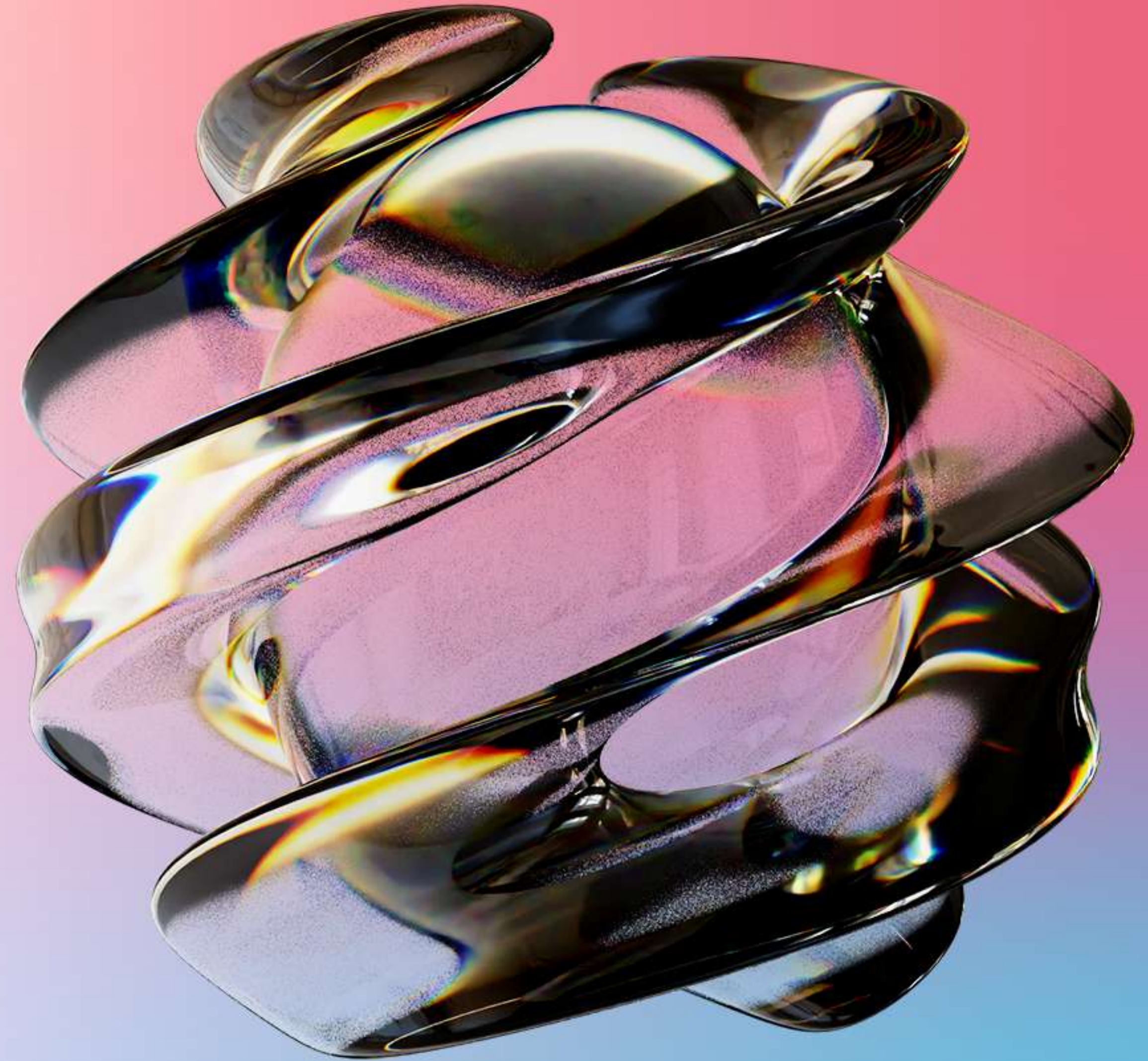
**Our Tokenomics are designed to provide long term stability for the project and encourage holding and mass adoption.**

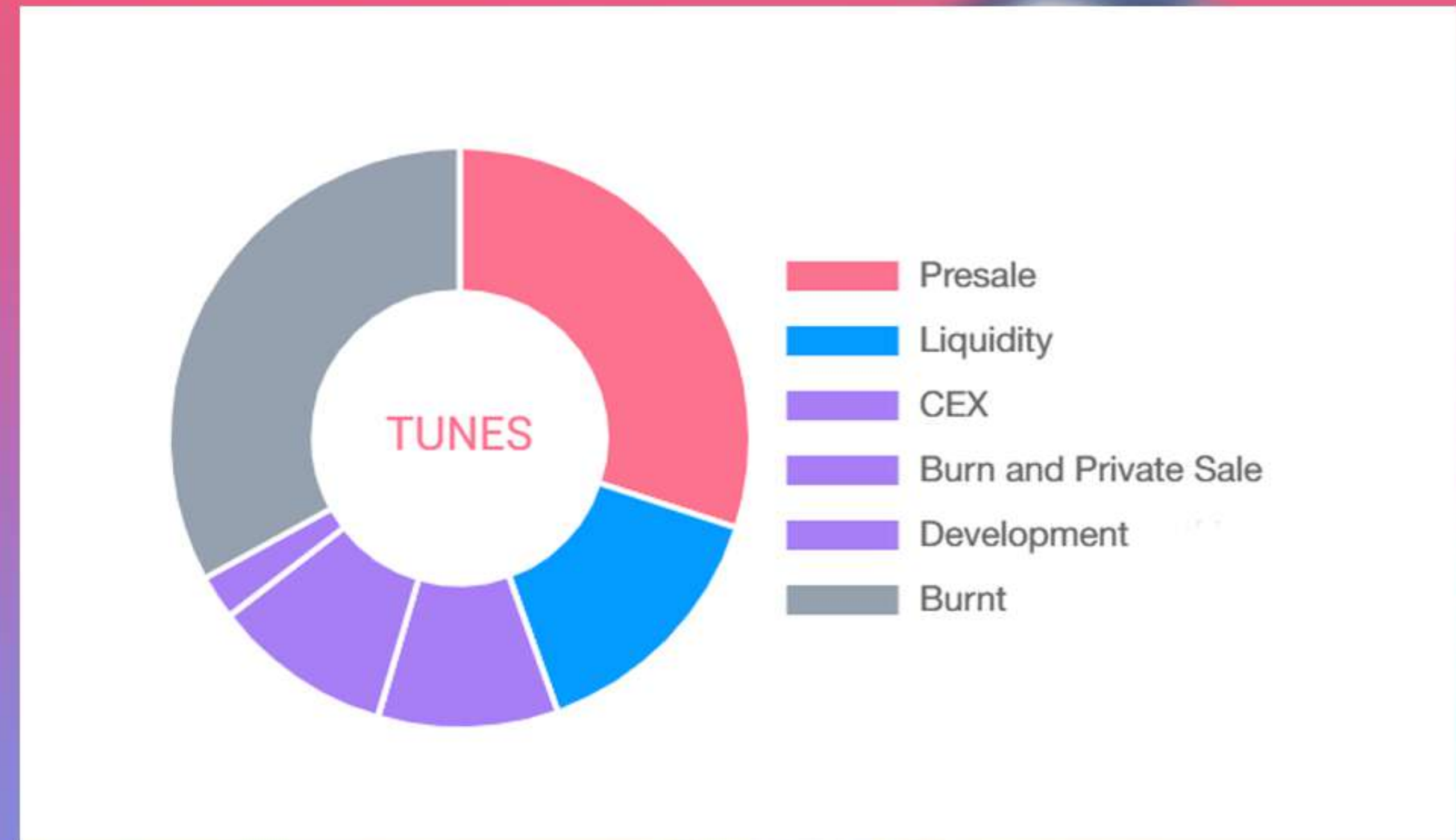

## **FIAT Subscription model:**

As part of our product roll out we will be implementing a FIAT subscription model. This will enable **non-crypto users** to make use of our product without the need to utilise cryptocurrency if unwanted.
